Dear Mr. Bachman:

This letter will serve as Oswego Community Unit District No. 308's response to your request dated May 21, 2014 received in our office on June 26, 2014, under the Freedom of Information Act (5ILCS 140/1 et seq.), in which you asked for the above referenced information. The District is including the names of the district's 2014 retiring personnel (see attachment) however, the District is declining to produce the home addresses and home telephone numbers responsive to your request under Section 7(1)(c) as personal information, the disclosure of which would result in an unwarranted invasion of personal privacy. The name of the person responsible for the partial denial of records responsive to this FOIA request is Victoria R. D'Aleo, Freedom of Information Officer. You may ask the Illinois Attorney General's Public Access Counselor (PAC) to review this decision concerning your records request, by submitting a Request for Review to the PAC by electronic mail or U.S. mail after this denial of your request. A Request for Review by the PAC should be directed to Public Access Counselor, Office of the Illinois Attorney General, at 500 S. 2nd Street, Springfield, IL 62706, publicaccess@atg.state.il.us. The PAC's telephone number is (217) 558-0486.

You also have the right to administrative review by a court of law pursuant to Section 11 of FOIA.
