On January 25, 2022, bids were publicly opened and read aloud for the above referenced project. Eight contractors chose to submit bids for the project. The low base bid was submitted by Helm Mechanical from Freeport, IL in the amount of \$1,437,000.00. The second lowest base bid was submitted by C Acitelli Heating from Villa Park, IL in the amount of \$1,495,000.00. See attached bid tabulation for details on bid results.

We conducted a Contractor Bid Scope Review with these bidders and believe their bids to be responsive and complete.

Therefore, the Board may wish to award a Contract to Helm Mechanical in the amount of \$2,095,000.00 which would include acceptance of Alternate No.1 for OEHS cooling tower work, previously bid last spring in the amount of \$140,000.00 and Alternate No. 2 for OHS replacement of two boilers in the amount of \$518,000.00
