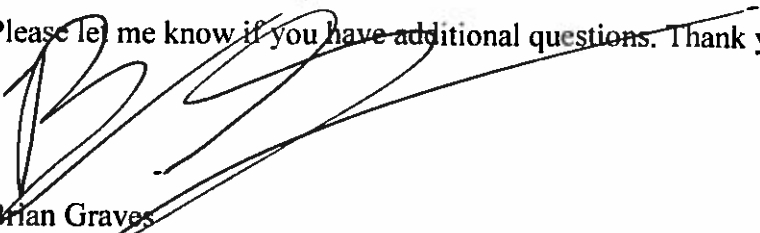
Dear Mr. Mihelich:
