Subject: A request for information is to gather additional information on teaching assignments (Regular Loads, Overloads, and Stipends) by school building type as it relates to the existing teacher collective bargaining agreement, and the additional compensation resulting from Overloads schedules. All information obtain will be used to evaluate the budget cuts.

- Please provide the total number of Junior High School teachers by building location that have either maintained regular load assignments or overload assignments (No Supervision) schedule during fiscal year 2014, 2015, 2016, 2017 and 2018.
- Please provide the total additional compensation or stipends paid (in summary) to junior high school teachers by building location for overload assignments (No Supervision) during fiscal year 2014, 2015, 2016, 2017, and 2018
- Please provide the total number of high school teachers by building location that have either maintained regular load assignment, Stipend (No Supervision) assignments or overload (No Planning Period) assignments during fiscal year 2014, 2015, 2016, 2017 and 2018.
- Please provide the total additional compensation or stipends paid (in summary) to high school teachers by building location for Stipend (No Supervision) assignments or overload (No Planning Period) assignments during fiscal year 2014, 2015, 2016, 2017, and 2018

The headcount data regarding the number of teachers with a "regular load" was compiled by calculating the number of teachers who received a paycheck coded to each building on December 30th of each year. For example, the December 30, 2013 payroll was used to calculate headcount for FY 2014. The current overload structure (overload in lieu of preparation period, stipend in lieu of supervision period) came into existence during Fiscal Year 2016 with the ratification of the current collective bargaining agreement, so no data could be provided for this at the high school level during Fiscal Years 2014 and 2015.
