Good Morning -

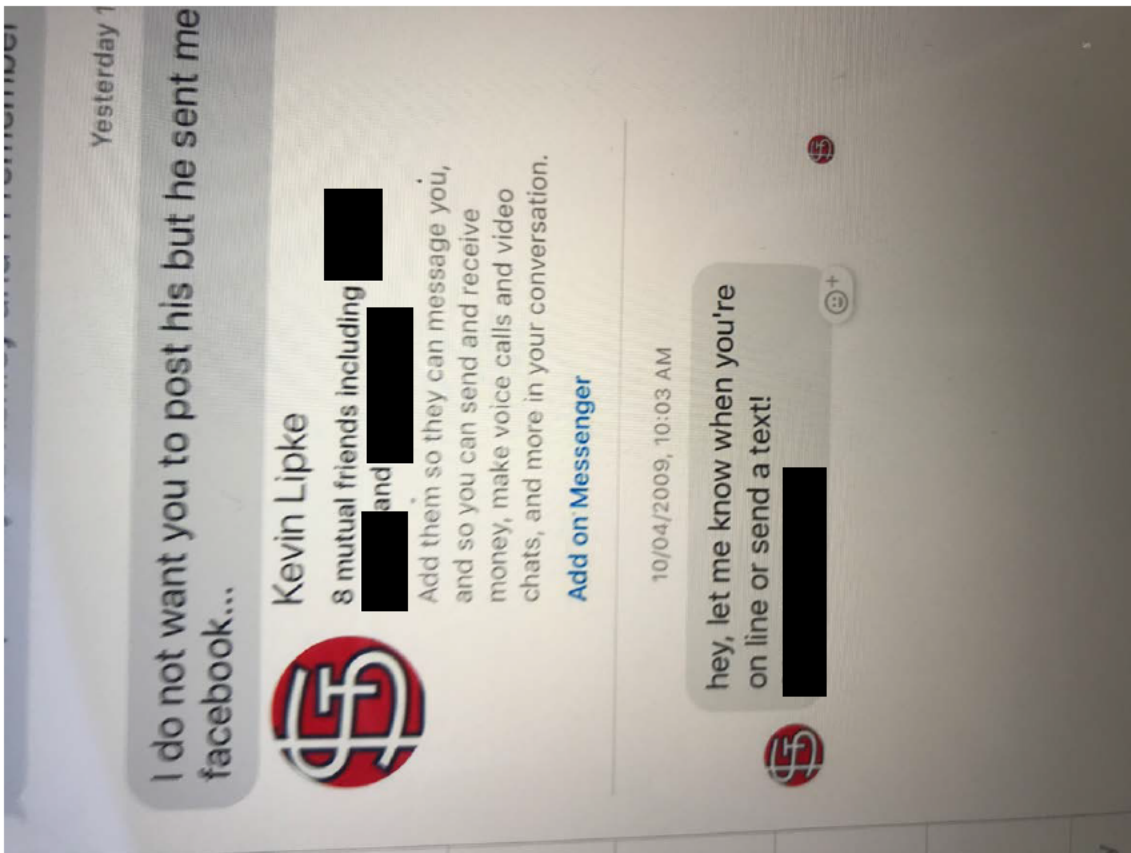
I spoke with a parent this morning who left a message for me yesterday. Attached is a screenshot of a private Facebook message her daughter received from Kevin Lipke (the former Long Beach principal who was just arrested for sexual assault of a minor in South Carolina). This message was sent in 2009 when the daughter was in 6th grade. The parent just wanted to let us know that this had occurred - she saw the news article about Lipke. She pointed out that the mutual friends listed were both 6th graders at that time.
