Oswego308.org - We do not have access to archived emails because the previous archive system (Postini) is no longer available. However, if you would like to log into her mthorson1012@oswego308.org, we could enable the account and provide you a default password. You could look through the email to see if there is anything you need. I show that their is 0.07GB of email. However, we do not have access to

anything deleted from this account.

Prior to 2003 the district used Yahoo Mail so we do not have access to any email before 2003.
