We are currently working on sponsors to help purchase supplies and are doing a community-wide supply drive during the month of July.

We are planning to do this on Saturday, August 8th. The only reason would we need to be inside a building at all is in case of inclement weather and that's just to store the bags while we are distributing. We are planning to do the sorting individually the week before so we don't have to worry about social distancing, etc. We anticipate that the car lines could be quite long, so that is another consideration. There is some desire to keep it in the Boulder Hill area (including Thompson) but we are open to anywhere you think would work.

I'm not really sure who I should talk to about this so you are the lucky ones to get my email. Ha! Please let me know if I need to contact someone else about this. I also welcome any feedback or ideas for the program whether we use a district location or not.



## Good Morning OE Family,

Now that the 20-21 school year is officially underway, I wanted to make sure to reach out to the Class 2024 and provide them with information regarding Oswego East Football. I am sure you didn't envision the start of your son's HS career would begin this way. All we can do is adapt and adjust. Due to the fact that last school year was cut short and we had an abbreviated summer camp, I felt it was important to our program to send out information pertaining to the football program.

Football at Oswego East is a No-cut sport. So any student that wants to join will be a part of the team. With the season being moved to the spring, there is no rush to make a decision now. I would also like to point out that previous experience is not required to join. We also have many multi-sport athletes that play football. So even if you play another sport, it is still ok to give football a shot. I know that injuries are often a concern for parents. Let me say that the game of football is safer than it has ever been.

I have finalized the Fall calendar and it is attached at the bottom of this email. I have also provided a link to a google classroom site (OE Football Class of 24) that we will use as one of our many communication tools. I know what you are thinking, great another google classroom!

As we get started, there are a few things that I want to give you some information about. First is our Fall calendar. The freshman team will be meeting on Tuesdays and Thursdays starting on Tuesday, Sept 1st. The first week will be from 5:00 to 6:00pm for weightlifting and speed training. Beginning on Tuesday, Sept 8th they will be practicing from 4:00 to 5:00pm followed by the weightlifting and speed training.

We will be following the same Covid-19 protocol that we did in the summer.


- -Temperatures will be taken upon arrival.
- -Players will answer Covid-19 screening questions.
- -Players will wear a mask at all times when inside.
- -When unable to social distance outside, players will be required to wear a mask.
- -All football related drills will be non-contact.
- -Players need to bring their own water bottles and towels
- -Anyone that is not feeling well should stay home.


We are providing a waiver for players to participate in 7 on 7 drills during fall practice. The waiver is linked below and it will be placed in the google classroom as well. The waiver needs to be signed and returned for players to be allowed to participate in 7 on 7 during practice.

Finally, starting the school year remotely with no football season presents an added challenge. We take the academic success of our players very seriously. We have had a team GPA of over 3.0 for 7 consecutive years. Typically we are able to track our athletes grades from the very start of the school year. Without having registration for football, we are working on a way to be able to check our players grades weekly. Players need to pass 5 classes in the fall to be able to play in the spring. I will even go a step further and talk briefly about the potential for our players to get recruited by a college and the impact that grades have on the recruiting process. In the last 8 years the Oswego East has had 65 players get an opportunity to play college football. There have only been 4 of those players that had a GPA under 2.5. More importantly than the number of players that have gone on to play college football is the number of players that have received academic scholarships to attend college. That number is much larger. We have had former players attend Ivy League schools, and high academic institutions like Northwestern, Stanford, and University of Chicago. It is very difficult to raise your GPA if it starts out low. This first semester it is critical to get off to a good start.



Good Morning Donna,

Last night I was forwarded the question you posed on Facebook. Please see my response below.

Your post on Facebook:

WHY, on Earth and for all that is Holy, were families allowed AGAIN to change the status for learning after we were all clear that the deadline back about 4-5 weeks ago was so that schools could adequately have time to alter schedules and class lists, create contact tracing seating charts, balance numbers in a room, and on and one??!! Staff, OEA LEADERSHIP and building admin were blindsided by a surprised memo from DAC that oops, now you all can change your minds! No consideration to the weeks on planning (while simultaneously teaching students) and extra work we have all put in, no warning, parents knew AGAIN, before staff did. And now, we are all managing our new semester changes and curriculum and having to once again REDO it all??!! This is total BS and I'm sick of it. So unprofessional and with no explanation WHY families were able to change their selections. Can ANYone explain it all to me? Very frustrating."

My response:

You stated that you were very frustrated because you had received no explanation. Please know that if I had received your question directly I would have answered it within 24 hours and provided an explanation. I am answering all the questions on the staff link on the website that we have provided so that staff can have their questions answered. I also am answering questions that staff send directly to me via phone or email. It is never my intent to have staff feel like there is no place to get answers. In fact, I work very hard at improving communication because I know it is the foundation of building relationships and trust.

I apologize that you feel that allowing parents to make a different choice was a surprise this week. That information was also included in the staff email that went out on Dec 18th. Even prior to Dec 18th, we had been allowing some parents to make the choice to move from in-person to remote because of some of the climbing covid rates. Some parents were feeling that that much had changed since they had made their choice in October so we had been allowing parents to switch. We put that information in the parent and staff email/video because we didn't want it kept as a secret.

Last week, we felt we needed to set a deadline to have all parents have made the choice so we could establish seating charts and class lists. That is the reason I sent out information to parents so that a deadline could be established. We also wanted to make sure that staff knew a deadline had been set. School administration had been informed of the deadline the day before.

I apologize that you are very frustrated. You posted that the decision to have a few parents make a switch of choices required a redo on curriculum. I do not understand that implication. Please call my cell at 630 222 8044 if you would like to explain that to me or talk further about your concerns. When you call, please let me know how many of your students made a switch. It is my understanding that it was very few, if any at all.

You mentioned in your facebook post that OEA and school leadership were "blindsided" by my email so I am copying them on this correspondence.

Please, as always, feel free to reach out to me directly when you have concerns. I believe that direct and open communication between the people in conflict usually helps ease frustration and misunderstanding better than postings of criticism on social media.

### Good morning Faith

If I am missing within the attached notification where staff was informed that parents would be able to change their HYBRID choices, please show me where I can reread that here. You mentioned we knew this prior to break.

Let me be clear on a few points... I am frustrated that teachers have been given several directives to update our hybrid class lists for groups A B C as well as our seatings charts. We were operating with the understanding that parent choices were finalized.

The lunch period in the schedule for junior high and high school students will be a study hall time during hybrid in-person learning.

### When do we choose and how long is the decision in place for in remote vs. inperson learning?

Parents of Elementary and the remaining Early Childhood students will receive the form Oct 15, it is due Oct 21. The decision is then in place for the 2nd trimester (Nov 9- Feb 12).

Parents of Junior High and High School students will receive the form on Oct 15, t is due Oct 21. The decision is then in place for the 3rd quarter (Jan 6- Mar 12).

# Will families still have the option to continue remote learning once in-person learning begins?

All parents/guardians will have the opportunity to register their student(s) for continued remote learning (Remote by Choice). The registration period for remote learning is staggered based on the proposed start day of in-person classes for each student group. Details will be sent to all parents/guardians when the choice to remain in a remote environment is due. Students without a Remote by Choice request on file by the designated deadline will be enrolled in the in-person

Personally, I believe if the plan changes that parents should get to change their decisions as well. But that is not at all my frustration or within my concentration. Then let's not have staff spend time finishing these by a December deadline (while simultaneously concluding semester with students and working on grades) for class lists and seating charts multiple times. That is my frustration that we keep having to redo these. Maybe this process takes more time then admin is aware of?


I have had multiple colleagues contact me sharing their tears, anxiety, frustration and feel the deadlines and decisions were set. In fact, I have spoken to two friends and veteran teachers in the past week who are now needing professional counseling to handle the stresses I posted about. This shatters me as a caring friend and colleague.

### In regards to the following,

You posted that the decision to have a few parents make a switch of choices required a redo on curriculum. I do not understand that implication.

With a new semester, teachers are concentrating on new Google Classrooms, changes in student schedules, finalizing and posting grades and planning for new curriculum units. The comment

about redoing was in regards to hybrid ABC lists and seating charts (more than once) at the same time. My Hybrid numbers does not alter what curriculum I teach.



While I was typing this reply, another veteran 308 teacher texted me that they have been in tears all morning and having panic attacks. I did my best to listen and suggest that they put aside their redoing charts and lists until after the BOE meeting hoping for a more definitive time table. No one likes to waste time reworking the same task so we might as well wait until the final changes come through.

Faith, none of this is easy nor are each of our roles within the district. I have approached this u usual time in teaching I. Stride and I am enjoying my students and classes with positive interactions and fun ways to learn remotely. Voicing my frustrations online or among private conversations is different for everyone.

You contacting me and my district leaders with what was shared online is one way to go. I wasn't aware that members of community fb groups were sharing a direct pathway to my questions or frustrations for personal replies. I appreciate the prompt response I received from you in regards to my concerns.

### Good Morning SD308 Staff,

We plan to move into hybrid instruction in a staggered approach. This is being done to make sure we have adequate assistance to support staff as they switch to new technology, new ways of tracking COVID for students and new modes of instruction. The emphasis is on moving our neediest and youngest students to the hybrid model as soon as we can.

Staff should be prepared to be at work in the schools for at least one full day on January 13th. Staff should also be prepared for students to move to the hybrid and remote by choice options as early as January 19th. Please review the schedules below for more details. We realize that we will need to watch COVID rates during Winter Break and may possibly need to change plans but we want the staff to know our most optimistic plans for returning students to some in-person instruction. We will provide another update by January 11th.

It is our hope that staff and students will work/learn more in person as the semester progresses.



Hi Robyn,

I have not heard this frustration concerning wasted food - but I just saw the FB post you made. I'm assuming this is coming from the amount of meals left over from the grab and go stations at the JHs and HSs. When these grade levels returned to school we needed to guess how many students who chose in-person instruction would actually take a bag. So more meals were delivered to the schools so that meals would be available to everyone who needed/wanted a bag. After a few days of monitoring how many bags were actually being taken at each building, an adjustment in the bag counts was made.

Having said all that, I'm sure there are still 'leftovers'. I do know that once the bag is delivered to the schools, our food service provider can not take them back - I believe this is a health/safety issue. I know some of our building admin have delivered extras to food pantries and/or to other places that provide meals to those in need. I would love to work with Community Cares in getting this extra food to families in need. I'll speak to Aramark and our building admin to get a sense of how many meals and what we can do to logistically make this successful. I'll be in touch very soon!

Hope you're doing well. I imagine you've heard that there are people in the community up in arms about the meals that are handed out. For some reason, people are really twisting it into a rant about how much food is being wasted. I know that many of the meals are frozen for future days, but I wanted to offer Community Cares as a partner to help minimize loss. We support three families with food each month, so sometimes people will give me extras from their bags and I give that to our families. I also accept the non-perishable food to distribute and put in the little pantry at the library. I don't know if the homeless shelters are accepting food, but we could arrange for drivers to transport it. If that is possible or if you have any ideas on how we can help support the program and help additional folks, I have volunteers clamoring to help.

I know how much good this program does for kids in the community so I really hate to see it attacked the way it has been the past few days. Hopefully, we can come up with something to quiet them and help even more people.

Yep. The bags have 3 days of breakfasts, lunches, and 6 milk cartons each day they are in-person - so twice a week. It was decided that these bags would be heavy/cumbersome for the little ones - especially if they have to climb the steps of a school bus. That's when the mid-day curbside was added so that parents could pick-up their students and drive directly to OH to pick up food. We have been averaging about 300 bags at the mid-day curbside service. When we started hearing from working parents who couldn't make the early morning or mid-day pick-up - we added the evening service. This just started yesterday - but they did 180 bags last night. We've also started publicizing that older siblings at the JH or HS could take extra meals for the younger ones - or for neighbor kids! We are trying everything we can think of to get food in the hands of the kiddos who need it - and are open to any ideas and truly appreciate you and your group of volunteers in helping us accomplish this goal!!!!
