Dear Mr. Granahan:

This letter will serve as Oswego Community Unit District No. 308's response to your May 16, 2014, request(s) under the Freedom of Information Act (5ILCS 140/1 et seq.), in which you asked for the above referenced information. Per my communication on May 23, 2014 the District extended the deadline for responding by an additional five (5) business days in accordance with Section 3(e) of the Freedom of Information Act.

District 308 is denying your request for information related to 1, 6, 8 and 13 pursuant to section 7(1)(c) as personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. District 308 has no records responsive to 2, 3, 4, 5, 9 and 10. Attached are records responsive to 7, 11 and 12. The records responsive to 11 have been partially redacted pursuant to section 7(1)(c) as personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

The name of the person responsible for the denial of records responsive to this FOIA request is Joe Deeney, Director of Human Resources. You may ask the Illinois Attorney General's Public Access Counselor (PAC) to review this decision concerning your records request, by submitting a Request for Review to the PAC by electronic mail or U.S. mail after this denial of your request. A Request for Review by the PAC should be directed to Public Access Counselor, Office of the Illinois Attorney General, at 500 S. 2nd Street, Springfield, IL 62706, publicaccess@atg.state.il.us. The PAC's telephone number is (217) 558-0486.

You also have the right to administrative review by a court of law pursuant to Section 11 of FOIA.


