Your company is invited to submit a Bid under seal to Owner (Oswego Community School District #308) for construction of the Oswego High School Track and Oswego East High School Track Bid Package located at 4250 Route 71, Oswego, Illinois 60543 and 1525 Harvey Road, Oswego, Illinois 60543 respectively. Owner will receive Bids at the SD308 Finance and Operations building located at 71 Stonehill, Oswego, Illinois 60543 until 10:00 AM local standard time on the 11th day of August, 2022, at which time and place the Bids will be publicly opened and read aloud. Bids not received by the indicated time will not be opened.

### Project Description:

#### **Oswego High School Track:**

Strip existing rubber track surface and clean surface. Installation of new latex bound rubber track surface.

**Project Description: Oswego East High School Track:** Grind off existing rubber track surface, mill existing asphalt surface, demo asphalt runway/pit for pole vault and runway for long jump, demo asphalt D-Zone. Place new asphalt surface course on track. Replace asphalt for pole vault runway and pit. Replace asphalt runway for long jump. Replace asphalt for D-Zone (North end). Construct new D-Zone at South end. Place new latex bound rubber surface over track, runways and D-Zones.

Alternate #1 – Demolish Existing asphalt pavement for track and replace with full depth asphalt.

Alternate #2 - Construction of concrete ribbon curb on inside and outside of track lanes.

Owner requires the Project to be completed by July 21, 2023.
