Your Company is invited to submit a Bid under seal to the Owner (Community Unit School District #308) for construction of the *Oswego High School & Oswego East High School Tennis Courts* located at 4250 Route 71, Oswego, Illinois 60543 & 1525 Harvey Rd, Oswego, Illinois 60543 respectively. The Owner will receive Bids at 71 Stonehill Road, until 10:30 AM local standard time on the 23rd day of February, 2023, at which time and place the Bids will be publicly opened and read aloud. Bids submitted later than 10:30 AM, after any bid package has been unsealed or read, will not be accepted.

Project Description: **Oswego High School Tennis Courts:** Demolition and reconstruction of the existing twelve (12) tennis courts. Re-construction to include installation of new fence, nets, structural fill, underdrain system, twelve (12) new tennis courts (in the same location), transitional grading, and apply final playing surface/striping for twelve (12) courts. \*Contractor to remove and reinstall existing blue screening on perimeter fence. \* Contractor Shall Coordinate with Owner on Storage of Screening.

Alternate #1 Tennis Court lighting to include light pole base, light pole and light heads.  
\*Work does not include installation of electrical infrastructure required for controlling or powering light poles.

Alternate #2 Construct new tennis court parking lot and parking lot lighting.  
\*Work does not include installation of electrical infrastructure required for controlling or powering light poles.

**Oswego East High School Tennis Courts:** Repair Cracks in asphalt, remove and replace heaved net posts and concrete, replace nets, apply final playing surface/striping for twelve (12) tennis courts.

Owner requires the Project to be completed by August 15, 2023.
